## Frequently Asked Questions

**Q: Will there be any type of orientation for admitted fall 2002 Cal State Channel Islands students?**

**A:** A comprehensive program called Island View Orientation is scheduled for July and August. Reservations are required and an invitation will be mailed to all admitted students. This is an important opportunity to become acquainted with the University and its many services, as well as meet with an academic advisor and register for classes.

**Q: When will student housing be available on campus?**

**A:** We anticipate that on-campus housing will be available in fall 2004. In an effort to preserve our beautiful 1930's architecture, current buildings will be renovated for campus residence halls.

**Q: Can I still apply to CSU Channel Islands for fall 2002?**

**A:** At the time this Schedule was printed, CSU Channel Islands remained open for fall 2002. Check with Admissions and Records at CSU Channel Islands if you are interested in applying for admission.

**Q: What student clubs can I join?**

**A:** One of the many exciting things that awaits you—our first class—is an opportunity to help form our student clubs. Students such as yourself will create a variety of clubs—social, academic, and sports—with the guidance and support of staff and faculty. Island View Orientation will give you more information about student clubs. Remember ... we're counting on you to become involved!

**Q: Cal State Northridge maintains a library on the Channel Islands campus. Will Cal State Channel Islands students have access to these library resources?**

**A:** Yes, you will have access to all library resources. Our new John S. Broome library is slated to open in 2005 and will be state of the art!

**Q: What should I do if I want to change my major? Or add a minor?**

**A:** If you are planning to change your major or add a minor, please call and schedule an appointment with the Academic Advisement Center. The Center will assist you with the change of major process and provide you with all appropriate paperwork.

**Q: How can I get advisement regarding the classes I should take this fall?**

**A:** Fall 2002 students who have been admitted will be invited to Island View Orientation. Plan to attend this important event to meet with program advisors and register for your classes. Be sure to respond to the invitation so we can prepare for your arrival.

**Q: Do I have to buy a parking permit to park on campus?**

**A:** Yes, you need a parking permit to park on campus. By participating in the Island View Orientation you will have the opportunity to speak with our parking services representatives and purchase your fall semester parking permit. Please refer to the Campus Services Directory in this Schedule for the phone number and location of Parking Services (Office of Public Safety). **Q: Will Cal State Channel Islands be adding more majors and minors? What about graduate programs?**

**A:** As Cal State Channel Islands grows, we will be adding more majors and minors each year, as well as Master's programs. Please check with the Academic Advisement Center for an up-to-date list of new degree programs planned for CSU Channel Islands.

**Q: Can I enroll in CSUN courses held on the Channel Islands campus?**

**A:** The CSU System has a program called "Intrasystem Concurrent Enrollment" which is designed for students wishing to enroll at two CSU campuses for one semester. You must meet certain requirements to participate in this program. Contact the Office of Admissions and Records for procedures and deadlines. Students receiving financial aid must contact the Financial Aid office prior to enrollment. Students should also meet with a Program Advisor to ensure they can receive appropriate course credit.

**Q: Will Cal State Northridge students attend classes here on the Channel Islands campus?**

**A:** Yes, Cal State Northridge has operated a satellite campus in Ventura County since 1974. In the summer of 1999, the Ventura campus relocated from the city of Ventura to the Channel Islands site and has been offering a number of degree programs since that time. Both universities—Cal State Channel Islands and Cal State Northridge—will continue to offer separate degree programs over the next few years. The programs offered by CSUN will gradually be brought to a close.

**Q: Will all of my classes be held in the Bell Tower Building?**

**A:** With the exception of a few courses, almost all of your classes will take place in the Bell Tower Building. Prior to the beginning of the semester, classroom locations will be posted via the web at: [www.csuci.edu](http://www.csuci.edu) under Schedule Of Classes.

## Academic Policies and Regulations

### Statement of Nondiscrimination and Disability Services Information

California State University Channel Islands prohibits discrimination or harassment based on sex, gender, race, color, religion, national origin or ancestry, age, disability, marital status, sexual orientation, cancer-related medical condition, or genetic predisposition. The University also prohibits discrimination against anyone due to a relationship or association with an individual with a known disability.

The University practices equal opportunity in admission to, access to, and operation of instruction, programs, services, and activities. Also, the University provides equally effective communication.

The University considers reasonable accommodation for these purposes (a) completion of the admission and enrollment processes, (b) participation in instruction, programs, services and activities, and (c) equally effective communication, upon request by persons with legally protected disabilities.

Questions, concerns, complaints, and requests for reasonable accommodation or additional information may be forwarded to the Office of Career, Health, Accommodations, Personal Counseling Services, (805) 437-8510 (voice and TDD).

### Use of Social Security Number

Applicants are required to include their social security number (taxpayer identification number) in designated places on applications for admission pursuant to the authority contained in Section 41201, Title 5, California Code of Regulations, and Section 6109 of the Internal Revenue Code. The University uses the social security number to identify records pertaining to the student as well as to identify the student for purposes of financial aid eligibility and disbursement and the repayment of financial aid and other debts payable to the institution. Also, the Internal Revenue Service requires the University to file information returns that include the student's social security number and other information such as the amount paid for qualified tuition, related expenses, and interest on educational loans. This information is used by the IRS to help determine whether a student, or a person claiming a student as a dependent, may take a credit or deduction to reduce federal income taxes.

### Privacy Rights of Students in Education Records

The Federal Family Educational Rights and Privacy Act of 1974 (20 U.S.C. 1232g) and regulations adopted thereunder (34 C.F.R. 99) set out requirements designed to protect the privacy of students concerning their records maintained by the campus. Specifically, the statute and regulations govern access to student records maintained by the campus, and the release of such records. In brief, the law provides that the campus must provide students access to records directly related to the student and an opportunity for a hearing to challenge such records on the grounds that they are inaccurate, misleading or otherwise inappropriate. The right to a hearing under the law does not include any right to challenge the appropriateness of a grade as determined by the instructor. The law generally requires that written consent of the student be received before releasing personally identifiable data about the student from records to other than a specified list of exceptions. The institution has adopted a set of policies and procedures concerning implementation of the statutes and the regulations on the campus. Copies of these policies and procedures may be obtained at the Admis-

sions and Records Office in the Bell Tower Building. Among the types of information included in the campus statement of policies and procedures are: (1) the types of student records and the information contained therein; (2) the official responsible for the maintenance of each type of record; (3) the location of access lists that indicate persons requesting or receiving information from the record; (4) policies for reviewing and expunging records; (5) the access rights of students; (6) the procedures for challenging the content of student records; (7) the cost which will be charged for reproducing copies of records; and (8) the right of the student to file a complaint with the Department of Education. An office and review board have been established by the Department to investigate and adjudicate violations and complaints. The office designated for this purpose is: Family Policy Compliance Office, U.S. Department of Education, Washington, D.C. 20202-4605.

The campus is authorized under the Act to release "directory information" concerning students. "Directory information" may include the student's name, address, telephone listing, electronic mail address, photograph, date and place of birth, major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, degrees and awards received, and the most recent previous educational agency or institution attended by the student. The above designated information is subject to release by the campus at any time unless the campus has received prior written objection from the student specifying information which the student requests not to be released. Written objections should be sent to the Admissions and Records Office in the Professional Building.

The campus is authorized to provide access to student records to campus officials and employees who have legitimate educational interests in such access. These persons are those who have responsibilities in connection with the campus's academic, administrative or service functions and who have reason for using student records connected with their campus or other related academic responsibilities. Disclosure may also be made to other persons or organizations under certain conditions (e.g., as part of the accreditation or program evaluation; in response to a court order or subpoena; in connection with financial aid; to other institutions to which the student is transferring).

## Academic Advisement

Cal State Channel Island's primary focus is on student-centered education and services. The academic advising mission is to promote student success by providing high quality advising services to all students.

For general advising and Liberal Studies advising students go the ACADEMIC ADVISING CENTER, located on the first floor of the Bell Tower Building. Students may schedule appointments with academic advisors Monday – Thursday, 8:00 – 6:00 p.m. and on Friday from 8:00 – 5:00 p.m. To schedule an appointment, please call 437-8571.

General advisors can assist students with:

- General education and graduation requirements
- Understanding institutional policies and procedures
- Information about academic probation policies, remediation strategies, and course repeat procedures
- Understanding degree audit and other University documents

## Registration Experience

### Purpose of the Schedule of Classes

As a Cal State Channel Islands Student, it is your responsibility to read and understand the Schedule of Classes. You are expected to understand academic policy, adhere to the academic deadlines and to follow correct registration procedures. The aim of this schedule is to provide you with the information you need to enroll in classes by:

- **Furnishing** a list of classes offered for the fall 2002 semester. When planning a schedule, you should be aware of any specific prerequisites.
- **Advising** you of current deadlines, fee information, etc. This schedule instructs you on where to seek advice on how to plan your academic schedule, how to change your program, and on other academic procedures.
- **Outlining** those courses that may be taken to fulfill general education requirements. Obtain an updated list of General Education requirements from the Academic Advising Center.

### Schedule of Classes via the Web

This schedule of classes is a guide only. While every effort has been made to ensure its accuracy, this information is subject to change without notice. Consult the University Catalog for the most current course descriptions and prerequisites.

The Schedule of Classes will also be available online for you to look up course information for the upcoming semester. Two weeks prior to classes beginning, visit the Website at [www.cscui.edu](http://www.cscui.edu) and see Class Schedule in order to check the location of your classes. Prior to the semester, easels will also be displayed at the front and rear entrances to the Bell Tower Building so that you may check the locations of your classes as well.

### Change of Program

It is your responsibility to initiate action when an adjustment in your program of study is necessary, i.e., adding, dropping or changing classes. Change of Program forms are available at the Office of Admissions and Records. Students are responsible for filing these forms properly and for paying the required fees. The filing period begins on the first day of classes. Students must file by the appropriate deadlines and are encouraged to file early. Note: It is your responsibility to ensure that all Change of Program forms are filed at the Admissions and Records Office by the appropriate deadline.

### **Adding**

All adds require instructor approval and signature on the Change of Program Form beginning with the first day of instruction.

**The last day to add a class is 4:00 p.m.,  
Friday, September 6, 2002**

### **Dropping**

A student may withdraw from any course during the first two weeks of instruction on the Change of Program form without an instructor's approval.

**The last day to drop a class is 4:00 p.m.,  
Friday, September 6, 2002.**

### **Changing**

Changing the basis of grading to Credit/No-Credit or to a regular letter grade can be accomplished during the first two weeks of instruction on the Change of Program form without an instructor's approval if that grading option is available.

**The absolute last day to change the basis of grading is  
4:00 p.m. Friday, September 6, 2002.**

### **Late Registration Period**

Late registration is conducted during the first two weeks of classes. You must secure a Change of Program form from the Office of Admissions and Records; obtain the approval of the instructor(s); and submit the form to the Office of Admissions and Records prior to 4:00 p.m. on Friday of the second week of classes. You may want to consult with the Academic Advising Center to plan your schedule. A non-refundable \$25.00 late registration fee is charged in addition to the regular registration fee. NOTE: You must be admitted to the University in order to register. All late registrations must be filed in the Office of Admissions and Records no later than 4:00 p.m. on Friday of the second week of classes.

### **Complete Withdrawal from the University**

Students who find it necessary to withdraw from CSU Channel Islands after enrolling for any academic term are required to follow the official withdrawal procedures. Failure to follow these procedures may result in the assignment of failing grades in all courses and the need to apply for readmission before being permitted to enroll in another academic term. Information on withdrawal procedures is available from the Advisement Office.

Students who are receiving financial aid funds must consult with the Financial Aid Office prior to withdrawing from the University regarding any required return or repayments of grant or loan assistance received for that academic term. If a recipient of financial assistance under federal Title IV financial aid programs withdraws from the institution during a payment period, the amount of grant or loan assistance received is subject to return and repayment provisions governed by federal law.

### **Nonattendance Policy**

An instructor may drop a student who does not attend class and has not made prior arrangements with the instructor. This may occur as early as the first class meeting.

### **Academic Program Verification**

At the end of the third week of instruction, the Office of Admissions and Records will mail students a copy of their official academic program. It is your responsibility to ensure that your academic program is accurate. Any enrollment discrepancies should be brought in person to the Office of Admissions and Records for correction. Students are encouraged to take immediate action; failure to correct an academic program discrepancy may result in a grade of "U" for an official enrollment in a course never attended.

### **Administrative Action on Prerequisites**

An instructor may drop a student who has enrolled in a class requiring permission of the instructor or completion of prerequisites if the student has not properly secured this permission or satisfactorily completed the prerequisites before enrolling.

### **Simultaneous Enrollment**

It is the policy of CSU Channel Islands that no student shall be permitted to enroll simultaneously in any two or more classes meeting during the same time period. An instructor may initiate the administrative withdrawal of a student enrolled in another class meeting at the same time.

### **Grade Policy**

1. The "ABCD" is the default grading system.
2. Although it is not required, individual faculty members may add a "+" or "-" to any grade except "F." By adding a "+" to a grade, the grade points earned increase by 0.3 (except an A+ shall still be 4.0 grade points). By adding a "-" to a grade, the grade points earned shall decrease by 0.3. Course syllabi are required to state clearly whether "+/-" grading is used.
3. A student may take a course "CR/NC" if the course is designated as allowing "CR/NC" grading in the course approval process.
4. Not more than 12 units of General Education courses may be taken "CR/NC."
5. The decision on how many units of courses taken "CR/NC" and which courses can be taken "CR/NC" is left up to each individual program.
6. Course syllabi shall include a discussion of the instructor's grading policy.

### **Policy on Course Grade Appeals**

1. Each student has the right to appeal the final course grade, but only the final course grade. A student may not appeal individual assignments and examinations.
2. Appeals are limited to situations in which the student believes the grade was "prejudicially," "capriciously," or "arbitrarily" assigned.
3. The appeal must be initiated within the first regular semester after assignment of the grade. It must first be directed to the instructor of the course, orally or in writing. If further action is necessary, the student should appeal in writing to the program





coordinator. If further action is necessary, the issue may be appealed to the University Grade Appeals Committee.

4. Individuals may not participate as a member of the University Grade Appeals Committee in the review of an appeal if they are a participant in an appeal.
5. The decision of the University Grade Appeals Committee is final.

### Policy on Forgiveness of Previously Earned Grade (Repeat and Delete)

You may repeat a course for the purposes of improving your GPA. Courses in which the grade is C or above can be replaced up to a maximum of 24 units; however, there is no limit on the number of units that can be retaken for courses with grades of C- or lower. Only the higher grade in a course will be used in calculation of the grade point average if forgiveness is granted.

### Policy on Honors at Graduation

#### University Honors:

The following honors are awarded to students graduating from CSU Channel Islands:

**Summa Cum Laude**—this honor is awarded to all students who possess a grade point average of 3.90 - 4.0 in courses taken at CSU Channel Islands.

**Magna Cum Laude**—this honor is awarded to all students who possess a grade point average of 3.75 - 3.89 in courses taken at CSU Channel Islands.

**Cum Laude**—this honor is awarded to all students who possess a grade point average of 3.50 - 3.74 in courses taken at CSU Channel Islands.

#### Program Honors:

Program honors will be awarded based on criteria developed by individual programs.

### Measles and Hepatitis B Immunization Requirements

All students born after January 1, 1957 are required to submit proof of measles and rubella immunization by the end of their first year. **Students will not be able to register for classes in their second year until this requirement is met.**

New students aged 18 or under are required to provide proof of full immunization against the hepatitis B virus prior to enrollment. Students who have not completed the series of 3 vaccinations will be given a grace period of 2 semesters in which to comply. **Students will not be able to register for classes in their second year until this requirement is met.**

### Policy on Credit Toward Graduation For Courses Taken Outside Cal State Channel Islands

A student may earn credit toward graduation for courses taken outside Cal State Channel Islands as follows:

#### Transfer of Undergraduate and Graduate Credit from Another Accredited Institution

Students who were in good standing at another accredited institution

may, within maximums, transfer credit for baccalaureate or graduate degree course work. Course equivalency for major requirements is subject to the determination and discretion of the University; students are cautioned that the University is under no obligation to accept transferred courses for subject credit in addition to unit credit for admission. The policy regarding transfer of courses from California community colleges differs in some respects. Individual program regulations for specific transfer limitations should be consulted.

#### Transfer of Undergraduate Credit from Accredited Community Colleges

A maximum of 70 semester units earned in a community college may be applied toward the baccalaureate degree, with the following limitations and stipulations:

1. No upper division credit may be allowed for courses taken in a community college;
2. No credit may be allowed for professional courses in education taken in a community college, other than introduction to education courses;
3. Students who transfer General Education certification are still required to complete at least 9 units of upper-division General Education courses at CSUCI.

#### Extension Courses

Students may take extension courses without matriculating at CSUCI provided that they meet course prerequisites. Extension courses may be applied to degree and credential requirements with approval of the degree program coordinator. Extension courses do not satisfy the University's residence requirement for graduation. Up to 24 units earned through Open University (see Open University) and Extension may be applied to a bachelor's degree, and up to 9 units may be applied to a master's degree.

#### International Program Credit

Course credits earned in universities abroad may be accepted for degree credit subject to evaluation by the Office of Admissions and Records. Specific course equivalencies may require consultation with individual program coordinators. CSU Channel Islands students who desire, subsequently, to take courses at a foreign university for degree credit must have each such course approved in advance in writing by the program coordinator.

### Special Enrollment Programs

#### Intrasystem Concurrent Enrollment

This program permits students to enroll for classes at Cal State Channel Islands and another CSU campus simultaneously. There is no limitation to the number of times a student may enter this program, as long as an application is filed each semester within the application deadlines outlined by the host campus. Please consult your program advisor and financial aid representative. Contact the Office of Admissions and Records for the Intrasystem Concurrent Enrollment application.

#### Intrasystem Visitor Enrollment

This program permits students to enroll solely at a CSU campus different from their home campus. Registration fees are paid to the host campus (the campus which the student is visiting). Financial aid recipients should check with a financial aid representative at their home campus.



### Procedure for Enrollment in Regular Classes Through Open University

Open University permits non-matriculated students to register in regular classes on a space available basis. Up to 24 units earned through Open University and Extension may be applied to a bachelor's degree, and up to 9 units may be applied to a master's degree.

Individuals who have not been formally admitted to the University may register through Extended Education as an Open University student for regular classes by securing the approval of the instructor and paying Extension fees. Students are expected to meet any course prerequisites and are subject to Open University Extension regulations regarding change of program, fees, refunds, and grades.

Students should attend desired classes for the first week. If space is available after the first week of classes, and with the appropriate approval, students may register at the Office of Admissions and Records. Full payment of fees is due at the time of registration.

Participation in the Open University Program does not constitute admission to the University nor does it entitle individuals to services available to regular students with the exception of library privileges.

### Refund of Registration & Nonresident Fees

Effective fall 2002, a new refund system has been approved by the CSU Board of Trustees. Significant changes have been made to the refund policy that will affect the amount of refund you may receive.

All refunds for mandatory fees are now automatic. Refund checks will be mailed to the address on file with Admissions and Records. Please make sure that your address is correct. Payments made by Visa or Mastercard will be credited back to the original card.

### Cancellation of Registration Prior to the Beginning of the Term

A student will be eligible for a full refund if fees are paid but no enrollment occurred or if all classes have been dropped prior to the first day of instruction for the term. Procedures for withdrawal are available in Admissions and Records or in this Schedule of Classes.

Students will also receive a full refund of mandatory fees and nonresident tuition under the following circumstances:

- The tuition and mandatory fees were collected in error
- The course for which the tuition and mandatory fees were assessed or collected was cancelled by the University
- The University makes a delayed decision that the student was not eligible to enroll in the term for which the mandatory fees were assessed and collected, and the delayed decision was not due to incomplete or inaccurate information provided by the student
- The student was activated for compulsory military service

**Prorated Refunds for Complete Withdrawals**

Beginning with the first day of instruction for the term, refunds for complete withdrawals will be prorated based on the date of withdrawal and the length of the academic period up to the 60% point of the term. Refunds are processed automatically. A student who officially withdraws after the 60% point in the academic period will not be entitled to a refund.

**Nonresident Fees:**

Nonresident students must pay the resident registration fees plus \$282.00 per unit. With prior approval, students have the option to pay registration fees in three installments. Check with Student Financial Services for complete details.

**Note:** In accordance with University policy, the Channel Islands campus gives preference in course enrollment to students already matriculated in the University. Individuals taking courses through "Open University" will be enrolled if space is available. (Fees subject to change by the trustees of the California State University; students will be billed for any fee increase approved by the legislature.)

**Registration Fee Installment Plan**

All students may apply to participate in the registration installment plan (IPP) to pay registration fees in a predetermined payment schedule. An approved IPP contract may be obtained from Student Financial Services. A student's prior financial activity must demonstrate credit worthiness in order to be approved to participate in the IPP. The IPP includes an initial payment and two additional payments during the current semester.

Installment Payment Plan applications and additional information are available at Student Financial Services. A non-refundable administrative fee of \$33.00 per semester is required for participation in the installment plan. The initial payment includes 1/3 of the state university fee and/or 1/3 of the applicable tuition charges, all campus based fees, and administrative fees. Two additional equal installments of the remaining state university fee and/or tuition charges will be due on the published due dates. Failure to complete your obligation under the terms of the IPP will result in the termination of University services and enrollment eligibility (disenrollment.)

**Financial Aid**

Students who have accepted a financial aid award will be able to postpone payment of registration fees until August 26th. Financial aid awards will first be used to satisfy any obligations owed to the university. If the total aid available is not sufficient to pay fees, or if the student loses financial aid eligibility, the student is responsible for payment of fees.

To qualify for a financial aid disbursement students must be enrolled in at least 12 units. This is considered the minimum full time load and will result in full financial aid eligibility. Students enrolling less than full time may have their aid reduced. Most financial aid programs have minimum unit requirements that must be met or aid from those programs may be cancelled completely. If you completely withdraw from school, you may be required to repay some or all of your financial aid.

**Special Course Fees (Lab Fees)**

Several courses require the payment of special course fees (lab fees) as a condition of enrollment. These fees are indicated in the Schedule of Classes next to the course listing. Students will be invoiced for lab fees incurred as a result of enrollment. Lab courses dropped by the refund deadline will automatically be credited on the student's account. Lab courses dropped after the deadline will require a Lab Refund form from the department. Lab fees may be paid with registration fees, when they are billed, or in person at Student Financial Services.

**Refunds for Partial Withdrawals**

A student who drops some, but not all units resulting in a lower tuition and/or mandatory fee obligation by the published deadline, will be entitled to a refund of the applicable difference in fees. Refunds are processed automatically. A student who fails to drop classes that would result in a lower fee category by the deadline will not be entitled to a refund.

**NOTE:** It is the sole responsibility of the student to withdraw from classes. Refunds can only be issued to students who withdraw from classes by the published deadlines. Students are responsible for verifying their withdrawal from classes.

## Transportation and Parking Services

Transportation and Parking Services (TPS) is a division of the Public Safety Department (PSD). We are located within Lot A1 on University Drive.

### Hours of Operation

Monday – Thursday 8:00 a.m. – 6:30 p.m.  
Friday 8:00 a.m. – 5:00 p.m.

Public Safety Dispatcher is available until 11:00 p.m.

During the first two weeks of the semester or session the hours of operation for Monday through Thursday are extended until 7:30 p.m.

### Parking Enforcement

All permit and parking regulations are enforced seven days a week, 24 hours a day. Vehicles parked on campus are required to have a parking permit. There is no grace period and cars without permits will be ticketed.

### Shuttle Service

A shuttle service is available Monday through Friday, 7:00 a.m. to 10:30 p.m., and Saturday, 7:30 a.m. to 5:30 p.m. The cost of a transit card is **\$25 per semester**, with no cost during summer session. The shuttle operates from the following sites:

#### Oxnard

“C” Street Transfer Point (adjacent to the back of the Centerpoint Mall)  
“C” Street & Channel Islands Blvd.

#### Camarillo

Camarillo Metrolink Station  
Lewis Road & Ventura Blvd.

To utilize this service and purchase your photo transit card, stop by TPS to complete an application and have your photo taken. Please allow 10 minutes to process your card.

The transit card is a countywide bus pass that can be used with other area transits that transfer to the CSUCI shuttles or you can park at one of the sites and ride the shuttle to campus. Parking at the sites is free.

### Parking Permits

Semester and daily permits are valid in all “A” Lots.

#### Semester

Semester parking permits may be purchased from TPS. You will need your student ID and vehicle license plate numbers when purchasing your permit. You may pay with cash, credit card, or write a check payable to CSUCI. The cost of the permit is \$89.50\* per semester.

#### Daily

Daily parking permits may be purchased from either the “blue” permit dispensers located in Lots A1 and A2 or the lobby of the PSD; and are valid only on the date of purchase. The cost of the daily permit is \$4.00\*. The dispensers will accept coins, and \$1, \$5, \$10, and \$20 bills; and give change in one (1) dollar coins.

### Metered Parking

Metered spaces are available throughout the campus. These spaces are for individuals who have short-term University business (45 minutes or less). Meters are not to be used for class-instruction or while taking finals. Permits are not honored in metered spaces.

### Federal Military Selective Service Act

The Federal Military Selective Service Act (the “Act”) requires most males residing in the United States to present themselves for registration with the Selective Service System within thirty days of their eighteenth birthday. Most males between the ages of 18 and 25 must be registered. Males born after December 31, 1959 may be required to submit a statement of compliance with the act and regulations in order to receive any grant, loan, or work assistance under specified provisions of existing federal law. In California, students subject to the Act who fail to register are also ineligible to receive any need-based student grants funded by the state or public postsecondary institution.

Selective Service registration forms are available at any U.S. Post Office, and many high schools have a staff member or teacher appointed as a Selective Service Registrar. Applicants for financial aid can also request that information provided on the Free Application for Federal Student Aid (FAFSA) be used to register them with the Selective Service. Information in the Selective Service System is available and the registration process may be initiated online at [www.sss.gov](http://www.sss.gov).

### Student Activities

The OSD Programming Board (PB) is a group of students who assist the Office of Student Development in the creation and administration of a variety of activities and events on the CSU Channel Islands campus. The PB is comprised of seven areas that entertain, educate and enlighten CSU Channel Islands students through sponsored activities. Each program area has a chair who is responsible to plan, coordinate, promote, and implement the various programs. Program areas include: Cinema, Concerts, Cultural Arts, Promotions, Special Events, Speakers, Video Productions, and Comedy.

### Student Clubs and Organizations

Student organizations at Channel Islands play an important role in the university community. They increase the vitality of the campus as well as providing leadership opportunities and community service. Organizations at Cal State Channel Islands provide a variety of opportunities ranging from sports clubs to politics. The university gains directly by the quality of the organizations, their programs, the leadership training and the quality of students involved in the clubs.

### Student Leadership

Leadership development at Cal State Channel Islands is designed to assist students in reaching their most effective level of leadership by providing opportunities, resources and training. Leadership training at Cal State Channel Islands is designed to provide consultation on a variety of topics through the use of presentations and interactive and participative activities. The Office of Student Development is responsible for Annual Student Leadership Retreat. Programs that promote leadership skills and development include the fall and spring Leadership





Retreats. Workshops and seminars will be presented by the Student Life staff on the following topics:

### **Recreation and Leisure Services**

Recreation and Leisure Services programs are sponsored by the Office of Student Development. These programs include recreational, leisure and wellness activities for all students. A variety of open recreational programs are available to students, including basketball, soccer, volleyball, softball, and hiking to name just a few.

Recreation and Leisure Services provides programming and activities in seven categories. The categories include: Informal Recreation, Intramural Sports, Sports Clubs, Health & Fitness, Outdoor Adventures, Instructional Programs and Special Events. The programming is structured to provide individual, dual and team competitions, workshops and instruction. This structure strives to provide a variety of recreational opportunities for a diverse student population.

#### **Informal Recreation**

This program provides an outlet for the entire university community to participate in a variety of sports. The Informal Program provides opportunities for individuals to participate at their leisure whether it be just shooting some hoops, playing in a small pickup game or working on skill development. The campus recreation areas will have specified hours designed for informal (open) play.

#### **Intramural Sports**

This program provides an outlet for the entire university community to join in on sport competition. The Intramural Sports Program provides a variety of structured sporting events to satisfy as many skill levels as possible. Scheduled tournaments, league play and challenges are offered. Opportunities include men's, women's and co-recreational play with appropriate rules presiding over each. Tournaments and/or leagues are offered in basketball, softball, volleyball, flag football, tennis, and golf.

#### **Sports Clubs**

The strength of the Sports Club program relies solely on the students. A sport club is a group of students voluntarily organized for the purpose of furthering their common interests in an activity through participation and/or competition. These interests may be competitive, recreational, instructional or a combination of these in nature. Clubs may represent the university in intercollegiate competition or conduct intracub activities such as practice, instruction, social and tournament

play. Sports clubs are designed to be a learning experience for the members through their involvement in fundraising, public relations, organization, administration, budgeting, marketing, management and scheduling, as well as the development of physical skills in the particular sport. Involvement in a group and team situation helps enhance the student's overall education while living in the university setting. Clubs may vary in focus and programming, even year to year, since the members are active participants in the leadership, responsibility and decision making process of the clubs' activities. Sport clubs are a great way for students to become involved in their campus community and make lasting relationships. All sports clubs must be registered with the Office of Student Life to be eligible for facility use and financial assistance at CSU Channel Islands.

#### **Health & Fitness**

The Fitness Center is home to the Health & Fitness component of RLS. The fitness area will provide opportunities to develop cardiovascular endurance, muscular strength, muscular endurance and flexibility. The cardiovascular amenities of the Fitness Center include: treadmills, stairclimbers, rowers, recumbent cycles, stationary cycles and elliptical trainers. The resistance training amenities include: selectorized stations, power cage, cable crossover, full selection of free weight benches, full selection of dumbbells from 2–120 pounds, and over 2,000 pounds of Olympic plates. The center also has stability balls, mats, jump ropes, and an aerobics program.

Trained student Fitness Instructors and Assistants staff the Fitness Center facility. Fitness Instructors and Assistants are certified in CPR and First Aid, as well as being trained in the principles of exercise, sports injury prevention, wellness, fitness assessment, and numerous components of pursuing a healthy lifestyle.

Cardiovascular training, general conditioning, resistance training and flexibility programs are offered free of charge to members of the Fitness Center. All potential members of the facility must complete a Fitness Orientation prior to utilizing the facility.

#### **Outdoor Adventures**

Our Outdoor Adventures program couples sport-like activities with the aesthetic pleasures of the outdoors. Outdoor Adventures utilizes nature's resources (lakes, canals, mountains, rivers, and wilderness) to challenge the physical body as well the mind.

#### **Instructional Programs**

The Instructional programs offered by RLS provide learning opportunities for participants in such a way as to improve their skills and knowledge in order to enhance enjoyment relevant to sports participation. 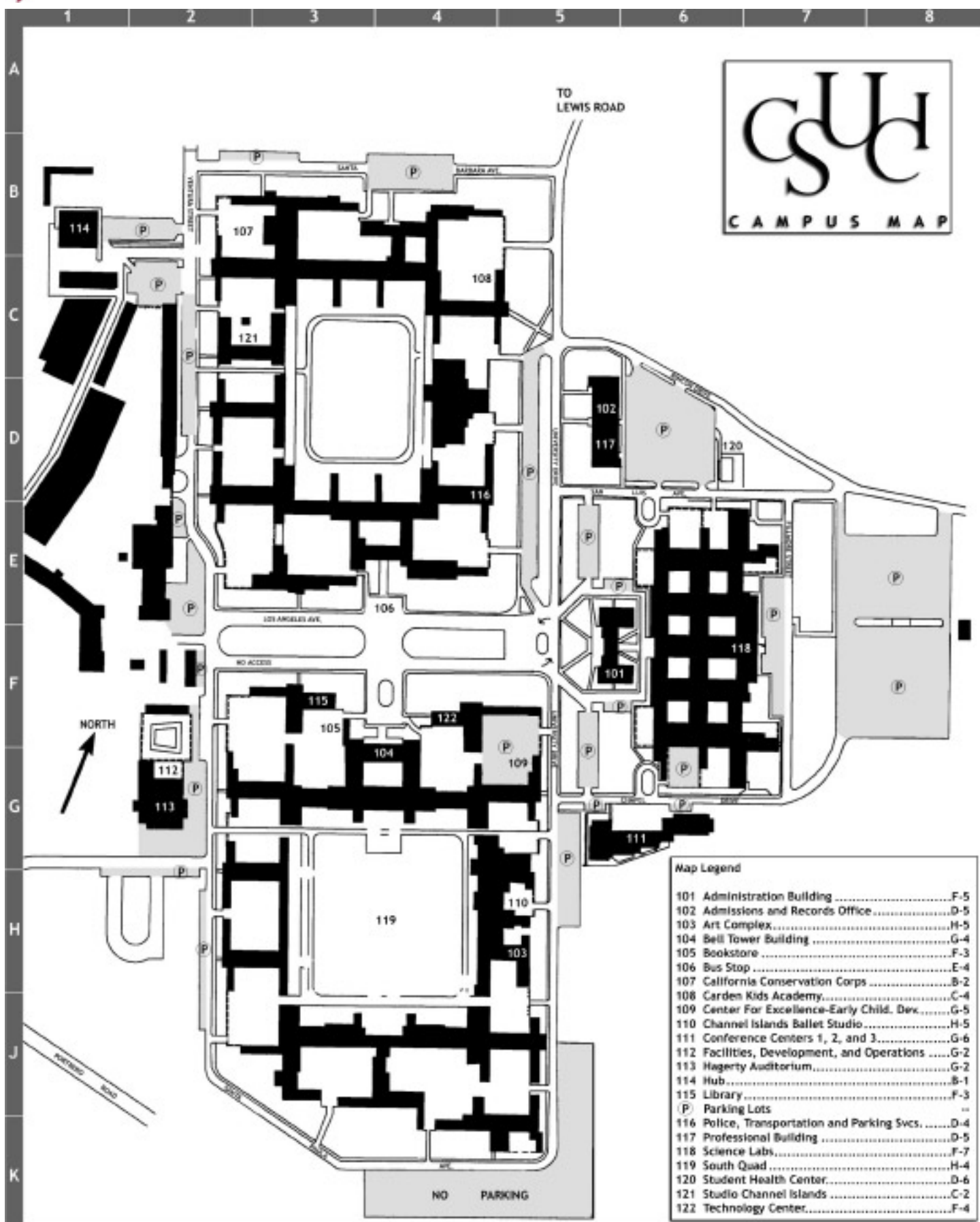

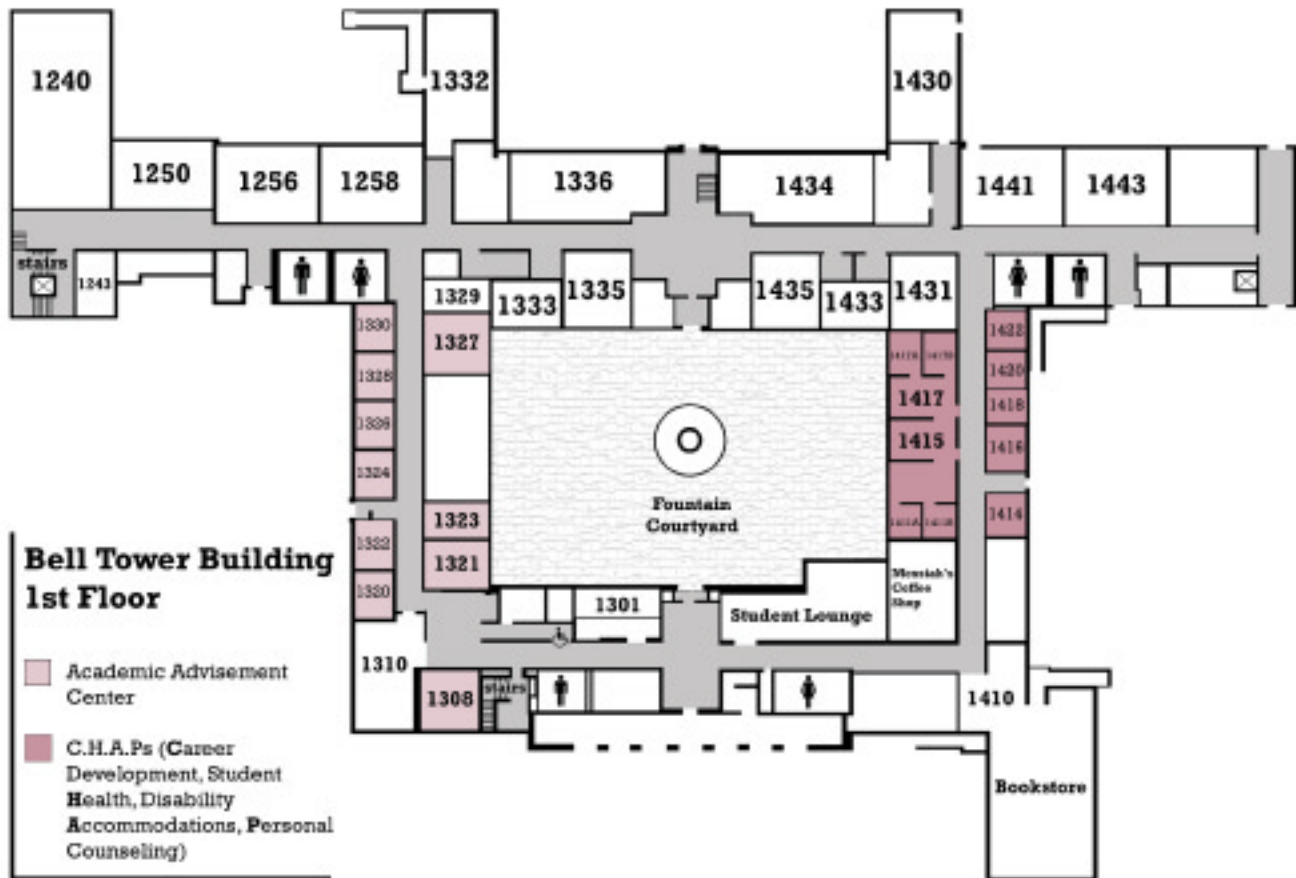

### Criteria for Late Add/Drop or Changes in the Basis of Grading

Students should note that a deficient academic performance is not a sufficient reason for dropping a class or changing the basis of grading.

The following examples do NOT meet the "serious and compelling/no viable alternative" standard to justify a "W" for dropping a course:

Need to work because of ordinary financial considerations or opportunity; encountered a situation which should have been anticipated, such as the need to have transportation, the need to pay for ordinary living expenses, the need for child care; dissatisfaction with course material, instructor, instructional method, or class intensity; lack of motivation or no longer relevant to academic interests, failing the class or receiving less-than-desired-grade; participation in extracurricular activities; or academic overload and cannot keep up in all classes.

All approvals for Changes of Program must be dated and secured within 14 days of the first approval received. The form must be filed at the Office of Admissions and Records.

A medical withdrawal usually constitutes complete withdrawal from the University for the academic period in question. In cases where medical evidence and the specific physical demands and environment of the classes overwhelmingly support withdrawal from only a portion of a student's program of study, partial withdrawals may be permitted. Medical withdrawals will be granted solely for established medical purposes prior to a student taking final exams. Medical withdrawals due to illness in the family will be granted only if the attending physician stipulates that the student is needed to care for the family member. A medical reevaluation is frequently required prior to readmission. The necessary forms for a medical withdrawal can be obtained at the Student Health Center. Approval of the instructor and Academic Affairs must be obtained for each class for which a medical withdrawal is sought.
